Health literacy as an important building block in the new Federal Agreement

A significant step forward in health literacy was recently highlighted in the Regeerakkoord (NL) (page 118) / Accord de Coalition Fédérale (FR) (page 123), which underscores the need to improve the health literacy of the population. The agreement states:

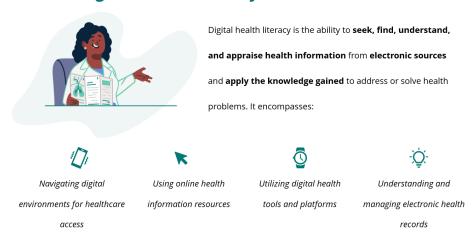
"We will improve the health literacy of the population. Our citizens must be optimally informed about health and well-being, and they should be able to quickly and easily access reliable information when needed. In this way, each citizen can make informed choices about health and a healthier life. Government websites must be easily accessible, clear, and tested according to these principles. Health insurance funds should also take on a greater role in this area."

This focus on health literacy sets the tone for our work in 2025...

Digital health literacy as our 2025 focus

In response to these national developments, HealthNest is excited to announce that **Digital Health Literacy** will be our central focus for the year.

What is Digital Health Literacy?



Digital health literacy goes beyond using technology—it equips individuals to evaluate, interpret, and act on health information effectively. It ensures people can assess the credibility of sources and make informed decisions to improve their wellbeing.

Why does it matter? While digital tools can transform healthcare, not everyone has the skills to use them effectively. Bridging this gap is essential for equitable access to healthcare and positive outcomes, enabling all individuals to make informed health decisions.



Our aim is to create practical tools, encourage collaboration, and spark important conversations that spread guidelines to organizations and policymakers around how to empower people to use digital health tools effectively.

HealthNest Digital Health Literacy Roundtable – February 3, 2025

HealthNest hosted a successful roundtable on Digital Health Literacy, gathering key stakeholders to discuss strategies and tools to improve digital health literacy across Belgium.

The roundtable included two keynotes: the first by Karen Van De Ginste from Mediawijs, which focused on strategies to improve digital health literacy through



key pillars such as access, competencies, and support networks. The second by **Dimitri Vanaeken from HealthHouse** who introduced the **DBS Select interactive patient education platform**, aimed at improving understanding of deep brain stimulation.

Following the keynotes, participants engaged in a group discussion addressing seven key questions around enhancing digital health literacy:

- 1. How do we increase people's ability to effectively use our digital health services: how do we ensure that users can find their way to these services?
- 2. How do we ensure that people can easily understand and use the health information we provide?
- 3. How can we better align our digital health services with the diverse needs of users?
- 4. How can we support users to be more actively involved in managing their own health through our digital health services?
- 5. What strategies can we implement to increase user motivation and encourage regular engagement?
- 6. How do we design digital health services so that users feel safe and in control of their personal health information?
- 7. How can we ensure that our digital health services are reliable, consistently available, and function well across different devices and platforms?
